3. Verify the fee challan form the Directorate of Treasuries and Accounts (Khazana Office) Government of KPK.

4. Submit the appeal fee in the State Bank of Pakistan or in any branch of National Bank of Pakistan.

5. Prescribed fee for individual and AOP taxpayers is Rs. 500/- and prescribed fee for Company is Rs. 1000/-

6. Completely fill the appeal form with the required information. Incomplete form will not be accepted.

7. Most of the required information is included in the Assessment/ Impugned Order issued by the Tax Officer.

8. Sign all the pages where required.

9. Use extra page for ground of appeals if required.

10. Attach original assessment order, original fee challan and any other supporting documents as needed.

11. Write page number on each page of the appeal and fill in the index of attachment.

12. Submit two copies of the appeal (one original set and one copy). Also submit one copy of the appeal with the tax officer who passed the order.

13. In case the appeal is time barred. Attach application for condonation of delay stating the reasons for delay.
